Full Member

Associate Member

A qualified hairdresser who has a financial interest in a full member's salon and is actively involved in the salon. No voting rights.

Affiliate Member

A person working within hairdressing related industry. (e.g. photographer) . This could be non-hairdressing partners, marketing consultants, advertising agencies, magazine publishers etc.) No voting rights

Interbeaute Member

A person in profession related to beauty and cosmetic industry (eg: make up artist; beauty therapist) Voting rights only on subjects related to the beauty industry

Guillaume Board Member

A qualified stylist who has represented Australia for Guillaume Internationally working in a full member salon. Membership remains only while in the employment of the full member. No voting rights

Guillaume Member

A qualified stylist or an apprentice/trainee working in a full member's salon. Membership remains only while in the employment of the full member. No voting rights
